

# Rockingham County Nursing Homes

Nursing homes provide up to 24 hour nursing care in addition to assistance with personal care needs (bathing, dressing, eating). The care provided may be long-term care for chronic conditions or short-term rehabilitative services for people who have been hospitalized. Nursing Facilities must be licensed in accordance with North Carolina state law by the North Carolina Division of Health Service Regulation. In addition, Nursing Homes that wish to receive Medicare and Medicaid reimbursement must be certified in accordance with federal law. Nursing Homes that are Medicare and Medicaid certified receive annual licensure inspections by the Division of Health Service Regulation.
